PROJECT INFORMATION

What - Elkader Byway Public Art Project

The City of Elkader is a byway community within the River Bluffs Scenic Byway Corridor. One of the byway's priorities is development and improvement of art and cultural resources. To act on this priority, a grant was acquired to help develop proposals for and the eventual funding of place-based public art.

The Elkader Art Advisory Committee will work with the Byways of Iowa Foundation and Northeast Iowa RC&D to fund the materials and artist fees associated with the project through grants, fundraising efforts, donations, etc.

Rules - Public Art Piece

Proposals are expected to:

- 1) be appropriate for all ages and to reflect the attached *Themes*. Elkader's theme(s) have been brainstormed through an inclusive process with interested Elkader citizens;
- 2) be an original expression and distinctive to attract and entertain visitors and residents of Elkader;
- 3) include intention and strategy for engaging the community (particularly youth) in the project; and
- 4) reflect a permanent, low-maintenance design.

Eligibility -

This call is open to all qualified artists or teams thereof 18 years of age and older. Priority will be given to Iowa artists and artists within or with close ties to the City of Elkader.

Note: If selected, artists will be asked to sign a contract taking on legal responsibility to complete this project.

Location - Founder's Park: Elkader, Iowa



The piece of public art developed will be located within Founder's Park in downtown Elkader.

Note: This location lies within a flood plain. The Elkader Art Advisory Committee will reserve the right to arrange landscaping as part of the project appropriate to the artwork and a plaque which will denote artist, public information about the project, funders, etc.

Project Timeline -

Project installation must be complete by February 28th, 2019.

Budget/Ownership –

Total project budget is in the range of \$7,000-\$10,000. Artist agrees if selected that the art piece will become the property of the City of Elkader once complete.

APPLICATION INFORMATION

Requirements -

Interested artists are required to submit the attached *Application Form* with the following attachments:

- 1. A one-page letter of interest concisely describing their qualifications and explaining why they are interested in working on this project.
- 2. A link to an online portfolio or an image sheet with no fewer than [5] and no more than [20] images of previous or relevant work labeled with location and date. Some, but not all, images can be of concepts that were not or have not yet been produced.
- 3. A proposed detailed budget within the range identified in this Call for Artists (include all artist fees, required materials, and installation costs).
- 4. A sketch or mock-up of Elkader public art proposal to show artist's potential concept.
- 5. An up to date resume or CV.

All submission materials must be in PDF format if emailed and paper-clipped if mailed.

Rubric

The Elkader Art Advisory Committee will take the following into account when reviewing applications:

- 1. Relevance of the piece to the community, its values, culture, and people
- 2. Plan for community engagement (particularly youth)
- 3. Suitability of the work for outdoor display, including its maintenance (permanent, low-maintenance)
- 4. Relationship of the work to the site and the host community, especially how it serves to activate or enhance public space
- 5. Appropriateness of the scale of the artwork
- 6. How closely the proposed artwork meets the goals set out in the *Call for Artists* and envisioned by the community
- 7. Artistic excellence
- 8. Inclusion of engaging and interactive designs
- 9. Evidence of working in the field of public art
- 10. Experience working in community settings
- 11. How the budget fits into the provided budget range
- 12. Connection of the artist to the community of Elkader
- 13. How willing the artist is to work with the Art Advisory Committee and Project Coordinator throughout the project
